Privacy Notice pursuant to Article 13 of the European Union Regulation 2016/679

AtemporaryStudio/PR di Felluga e Punis, in its capacity as processor of personal data, provides the following information to its customers as part of its Privacy Policy. The updated and complete Privacy Policy is always available for consultation upon request.

Legal basis and purpose of the processing.

The processed data relating to members consists of personal details, contact details and billing information of the entities involved in contractual relations, obtained and collected through communications exchanged for the establishment and execution of a contract, to fulfil legal obligations in addition to the pursuit of the legitimate interest of the Owner in providing for the protection of his rights as well as the management of the professional purposes inferred in the contract.

The data collected will be used for the following purposes:

- a. Execution of pre-contractual and contractual measures;
- b. Compliance with legal requirements;
- c. To provide assistance;
- d. Storage and retention.

If consent is given, such data may be processed for marketing purposes with the sending of catalogues, promotional e-mails, invitations and subscriptions to mailing lists. Consent can be given by a request to subscribe to the mailing list, completion of the registration form on the website, written subscription.

Provision of data.

The provision of data is mandatory for the pursuit of the stated purposes, whether accurate or inaccurate. In the absence of consent, the data will be processed for the purposes referred to in points a, b, c, d.

Method of treatment.

Categories of recipients. Transfers to third countries or international organizations. The processing of collected data is carried out using manual, computerized and telematic tools, including recourse to third parties specifically appointed as data controllers. Any automated decision-making processes (for example, profiling) and

the dissemination of data are excluded.

The data collected and processed will also be communicated, within the limits of the purposes to be pursued, to business partners and consultants of the Owner in relation to the contractual activity, and also to banking and insurance institutions for the management of payments and to public administration bodies to fulfil legal obligations.

Retention period.

The collected and processed data is stored as long as the business relationship is in effect, and will be deleted at the expiration of the ten-year period of limitation of rights.

Rights of the interested party.

It is the right of the individual to whom the processed data refers to obtain access, rectification, cancellation of the data processed or otherwise request the limitation or oppose the processing, in addition to requesting the portability of the data provided. It is also the right of the interested party to submit a complaint to a supervisory authority such as the Personal Data Protection Authority.
